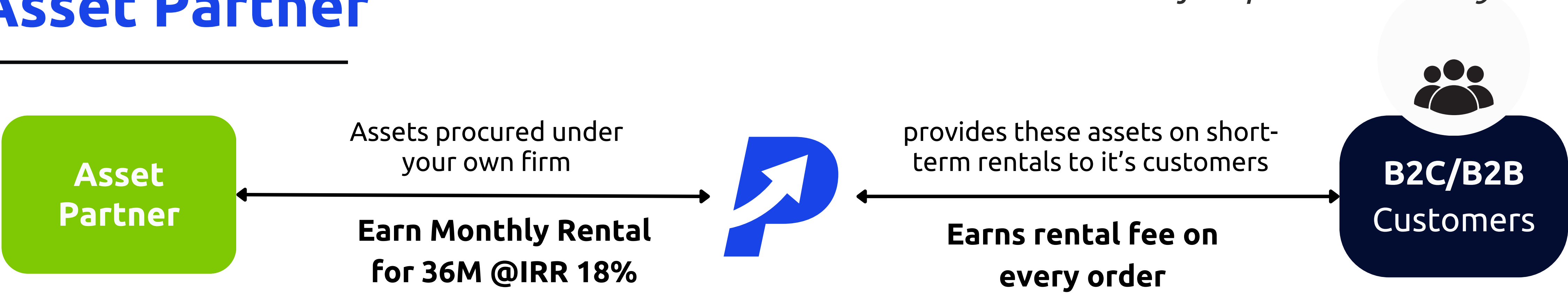

Frequently Asked Questions

Why have you started this program?

A lot of customers like yourself love our services and keep enquiring as to how they can contribute & partner with us. So we thought of coming up with a solution which mutually benefits everyone in the ecosystem.

Are the monthly rentals fixed or does it depend on the number of times it is rented?

No, the rental amount is fixed when the agreement is initiated. You will continue to receive the agreed rentals irrespective of the number of times it is rented.

How is the ownership transferred to me?

Once you make the invoice payment you simply become the owner of that product. The goods are not physically transferred to you. The billing address on the invoice will be yours and shipping address will be SharePal's warehouse.

Frequently Asked Questions

What is the rental agreement about?

It is a simple agreement through which you allow us to use the product for renting to our customers. Also it mentions that once the rental period has ended the ownership of the product is transferred to SharePal.

If the XIRR is 19.2% shouldn't the total income earned be equal to Rs.59600, if I buy assets worth Rs.50000?

If you calculate a simple interest then this calculation is right. However In case of simple interest, the principal & interest is paid together after the 1 year period is complete. As it is rentals in this case, we pay a monthly rent of ₹4570/- every month thereby reducing the principal amount. To capture this we calculate XIRR which is 19.24%.

What is XIRR?

XIRR stands for Extended Internal Rate of Return is a method used to calculate returns on investments where there are multiple payouts happening during the investment/rental period.

Frequently Asked Questions

Can I decide what I want to buy?

No, we decide what needs to be purchased based on which products are in high demand for renting and what are our current inventory levels.

Do I get the products back after the rental period is over?

No, the ownership of the products is transferred to us after the rental period is over. Once the products are used for 12 months they are sold at salvage value.

Why should I do this?

There are multiple benefits. Firstly you contribute to a sustainable way of consumption. Secondly the returns are very good compared to regular investments and you earn a fixed stream of rentals. Thirdly you can make your orders virtually free by using the wallet credits and rentals earned.
